**Localism Act 2011, Sections 28 & 29  
The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012**

In order to comply with the Parish/ Town Council's Code of Conduct, a Member or Co-opted Member must register their pecuniary and interests other than pecuniary interests with the Borough Council's Monitoring Officer within **28 days** of the date of their election or co-option. *(failure to declare a disclosable pecuniary interest is a criminal offence).*

Note – A Member must, within 28 days of becoming aware of any new non-pecuniary interest or change to any pecuniary interest specified above, register details of that new pecuniary interest or change by completing a new Register of Interest Form and submitting it to the Borough Council's Monitoring Officer.

***Important Notes – You may complete this form electronically but you must print it out and personally sign the completed form.***

*If in doubt about whether or not something should be declared, you are urged to err on the side of openness and avoid the risk of not registering something in error.*
